I, \_\_\_\_\_, hereafter referred to as the adopter; hereby agree that the above-referenced Sugar Glider(s) is/are being adopted by me as a pet for me and/or my immediate family. I agree to pay the adoption fee/purchase price of \$\_\_\_\_\_, and understand all monies paid to **Shelly Sterk** are nonrefundable unless otherwise stated in this document. If a glider dies prior to delivery, all monies will be refunded.

The above-referenced Sugar Glider(s) has a 72-hour health guarantee (equivalent of three days) if the Sugar Glider(s) is/are taken to the vet within 48 hours of arrival for a health check or sooner if the Sugar Glider(s) is/are showing signs of illness. All fees, tests, and vet bills are the responsibility of the adopter, unless noted below. The above-referenced Sugar Glider(s) must NOT be in contact with other animals during the warranty period. Failure to comply will void the health guarantee. Should the above-referenced Sugar Glider(s) become ill within 72 hours due to parasites or a similar condition that is directly related to **Shelly Sterk** or her establishment, and the glider has not been exposed to any other animals, Shelly Sterk will pay vet bills directly related to the medical condition. A medical exam will be needed by a qualified veterinarian to prove illness and its origin. Should the above-referenced Sugar Glider(s) pass away within the 72 hours due to parasites or similar condition that is directly related to **Shelly Sterk** or her establishment and the glider has not been exposed to any other animals, the adopter has the right to receive a refund for the purchase of the Sugar Glider(s) only (excludes shipping/transportation fees), or a replacement of the Glider(s) with the next available Glider(s) of equal value of the adopters choice. A medical exam/necropsy will be needed by a qualified veterinarian to prove a covered illness at the expense of the adopter.

This Sugar Glider(s) is placed as (Choose one box):

This is a pet that is NOT to be bred. I agree to abide by this private agreement with **Shelly Sterk** on the above-referenced Sugar Glider(s).

Any violation and/or breach of this private agreement will constitute an agreed amount of set fines as follows:

- \$500.00 fine for each breeding breach
- \$250.00 fine for each offspring of the above described Sugar Glider(s).

The breaching party is responsible for all legal expenses. If the above-referenced Sugar Glider(s) is/are bred while this private agreement is in effect, ownership and physical possession of the Sugar Glider(s) and all offspring shall immediately revert to **Shelly Sterk** with no compensation to the adopter.

**I will not breed the above-referenced Sugar Glider(s). I understand if I breed the above-referenced Sugar Glider(s) on purpose or by accident, will constitute a violation of this private agreement. Set fines mentioned above are due and payable immediately to **Shelly Sterk**.**

Trauma, stress related illnesses, and bacterial infections are NOT covered. Adopter is responsible for watching for stresses or stress related symptoms. Should symptoms arise, adopter is responsible to get the Sugar Glider(s) to the vet immediately. All veterinarian bills incurred for stress related illnesses will be the responsibility of the adopter.

**This health guarantee does not cover accidents, neglect, or mistreatment of any kind.**

The adopter agrees that he/she will not sell, give away, or otherwise dispose of said Sugar Glider(s) to any dealer, retailer, auction, institute or any other similar entity or abandon said Sugar Glider(s) for any reason. If at a later date, the adopter is unable or unwilling to keep said Sugar Glider(s), he/she agrees to first contact **Shelly Sterk** to take back said Sugar Glider(s). If Shelly Sterk is unable or unwilling to reclaim said pet(s), the adopter will place the pet privately. If needed, Shelly Sterk agrees to mentor the new owner in all aspects of sugar glider care to help ensure a quality home.

The adopter hereby agrees to care for the above-referenced Sugar Glider(s) in a humane and responsible manner and to provide it with clean and adequate shelter, food, water, and veterinary care if the Sugar Glider(s) becomes ill or injured. The adopter agrees to contact **Shelly Sterk** OR send an update to the database for inclusion in this Sugar Glider's registration file if this pet becomes seriously ill or develops a condition that may be genetic, and when the Sugar Glider(s) dies – this is for the purpose of the breeder being able to take into consideration all known aspects of the lines genetic health. Additionally, the adopter agrees to meet all special needs or requirements of adopted Sugar Glider(s).

This is a pet that may be bred for the improvement of the species. If I breed this pet, I agree to register the resulting litter(s) with the database, or notify **Shelly Sterk** for the purposes of continuing the awareness of genetics, health, and temperament in current and futures offspring in this line. I have reviewed the Sugar Glider's pedigree which has all occurrences of any genetic diseases or defects recorded that are known to **Shelly Sterk** at the time of this sale. Knowing this Sugar Glider's background, I take full responsibility for the results of breeding this Sugar Glider(s) and understand that there is no guarantee regarding the fertility of this Sugar Glider(s) or its offspring.
