

TERMS AND CONDITIONS FOR DOWNLOAD, INSTALLATION AND USE OF THE "GLIDERS IN NATURE" SCREENSAVER ("Terms and Conditions")

This is a legal agreement between you (referred to in this agreement as "You" or "Your") and Glider Nursery, a sole proprietorship under Ohio law.

BY CLICKING ON THE "ACCEPT" BUTTON, INSTALLING OR OTHERWISE MAKING USE OF THE "GLIDERS IN NATURE" SCREENSAVER (which shall be referred to as "Gliders in Nature", throughout these Terms and Conditions) YOU ARE AGREEING TO BE BOUND BY THESE TERMS AND CONDITIONS. IF YOU DO NOT WISH TO BE SO BOUND, DO NOT DOWNLOAD THE SOFTWARE.

ARTICLE 1. THE SCREENSAVER

"Gliders in Nature" is a screensaver created by Glider Nursery.

ARTICLE 2. LICENSE

2.1 Glider Nursery grants you a personal, non-exclusive, non-transferable license to use "Gliders in Nature". The term "Gliders in Nature" includes all aspects of the screensaver, including without limitation its technical capabilities, code, text, graphics, logos, trademarks, content or material. You may only use one copy of "Gliders in Nature", however you may make one back-up copy, provided that such copy shall be subject to these Terms and Conditions.

2.2 You may only use "Gliders in Nature" for your personal (including in your work environment) non-commercial use.

2.3 For use in public venues (such as, but not limited to, exhibitions, festivals, events, etc.) prior consent of owner, Glider Nursery, is required. In order to obtain such consent, please email GliderNursery@gmail.com.

2.4 You may not copy, modify, alter or make any changes to "Gliders in Nature" or any party of it or remove any watermark or copyright notice or the present license agreement. You may not rent, lease or license (whether for a fee or otherwise), or make available to others "Gliders in Nature" or any copy of it.

ARTICLE 3. INTELLECTUAL PROPERTY RIGHTS

All intellectual property rights in "Gliders in Nature" are owned by Glider Nursery (or its licensors) and are protected by Ohio intellectual property laws, international treaty provisions and other applicable national laws.

ARTICLE 4. EXCLUSION OF WARRANTIES AND LIMITATION OF LIABILITY

4.1 "Gliders in Nature" is provided "AS IS" and you are using it is at your own

risk. "Gliders in Nature" may contain significant or insignificant program errors, bugs and viruses, which may cause an operational interruption to your computer system. You must screen "Gliders in Nature" for viruses before downloading to your computer.

4.2 Except to the extent that such terms cannot be limited or excluded by law, no conditions, warranties, representations or other terms, whether express or implied shall apply with respect to "Gliders in Nature".

4.3 Except to the extent permitted by law, and in particular except in cases of fraud or gross negligence, Glider Nursery disclaim all liability (howsoever arising) in connection with any loss, damage and/or expense arising out of or in connection with downloading, installation or use of, or inability to use "Gliders in Nature". In particular and without limitation to the generality of the above, Glider Nursery shall not be liable for any: loss of use of or damage to a computer equipment, software or data; any financial loss; indirect, special or consequential loss or damage.

ARTICLE 5. TERMINATION

5.1 Your license automatically terminates if You do not comply with any provisions of these Terms and Conditions.

5.2 Upon termination of the license you must destroy all copies of "Gliders in Nature" in your possession.

5.3 Glider Nursery may discontinue the provision of "Gliders in Nature" at any time.

ARTICLE 6. APPLICABLE LAW AND JURISDICTION

These Terms and Conditions shall be construed and governed by the laws of Ohio.

Any dispute arising in connection with the validity, interpretation or execution of these Terms and Conditions shall be submitted to the exclusive jurisdiction of Lorain County, Ohio.
